

Subject: Compliance with Reach Regulation EC1907/2006, Waste Framework Directive 2008/98/EC, RoHS Directive 2011/65/EU

European Regulation 1907/2006 REACH concerning the Registration, Evaluation, Authorization and Restriction of Chemicals defines Article as “an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition”.

Based upon that definition, the products sold by BOTECO Srl are classified as articles.

The EU has established that those who produce, assemble, import or distribute articles in the EU or, in general, all those who introduce articles into the European market (supplier of an article), commencing from 5 January 2021 will be required to make a notification to the SCIP DATABASE only if the articles contain substances of very high concern (SVHC) according to the Candidate List with a threshold higher than 0.1% (by weight).

Currently, the Candidate List contains, inter alia, the following substance which may be contained in our articles:

LEAD (no. CAS 7439-92-1, EC no. 231-100-4)

Lead may be contained as an alloy element in a concentration higher than 0.1% of the weight of the article, in mechanical construction elements. For example:

- Free-cutting steel (e.g. AVP, PR80)
- Copper alloys (e.g. brass, bronze, etc.)
- Aluminium alloys

In light of the above, we declare that the articles supplied to you may include SVHC listed in the “Candidate List” updated at 23 January 2024, beyond the set limits.

Below is the complete list of codes by product Group in which there are SVHC in a concentration higher than 0.1% w/w, with respective SCIP NUMBERS (Annex I)

The correspondence of the product identifier (TARIC code) with the definition of the product Group distributed by BOTECO Srl is indicated in the table in Annex II.

With this communication the obligation to disclose the presence of an SVHC in articles is met, as envisaged by Art. 33 of the Reach Regulation, EC 1907/2006.


The articles supplied by BOTECO Srl are compliant with the provisions of RoHS Directive 2011/65/EU as amended and supplemented.
